Event Sponsorship Terms and Conditions

These Event Sponsorship Terms and Conditions (“Terms”) govern the relationship between the Event Organizer Postal and Telecommunications Regulatory Authority of Zimbabwe (POTRAZ) and the Sponsor (“Sponsor”) in connection with sponsorship of the event described in the Sponsorship Agreement or Proposal (“Event”). By confirming sponsorship, the Sponsor agrees to be bound by these Terms.

1. SPONSORSHIP PACKAGE AND BENEFITS

- 1.1 The sponsorship level, benefits, deliverables, and fees shall be as outlined in the agreed Sponsorship Proposal or Agreement.
- 1.2 All benefits are subject to availability and timely provision of required materials by the Sponsor.
- 1.3 The Organizer reserves the right to make reasonable changes to the Event program, speakers, venue, or format where necessary.

2. FEES AND PAYMENT

- 2.1 Sponsorship fees are payable in full within the timelines specified in the invoice or Sponsorship Agreement.
- 2.2 All fees are exclusive of applicable taxes unless stated otherwise.
- 2.3 Failure to make payment by the due date may result in suspension or cancellation of sponsorship benefits without liability to the Organizer.

3. USE OF NAMES, LOGOS, AND INTELLECTUAL PROPERTY

- 3.1 Each party grants the other a non-exclusive, royalty-free license to use its name, logo, and trademarks solely for the purposes of promoting the Event.
- 3.2 The Sponsor warrants that it owns or has permission to use all materials supplied to the Organizer.
- 3.3 All intellectual property rights not expressly granted remain the property of the respective party.

4. SPONSOR OBLIGATIONS

- 4.1 The Sponsor shall provide accurate branding materials and content by the deadlines communicated by the Organizer.
- 4.2 The Sponsor shall ensure that all promotional activities comply with applicable laws, regulations, and industry standards.
- 4.3 The Sponsor shall not engage in any activity that may bring the Event or Organizer into disrepute.

5. EVENT CONDUCT AND COMPLIANCE

- 5.1 The Sponsor, its representatives, and guests shall comply with all Event rules, venue regulations, health and safety requirements, and applicable laws.
- 5.2 The Organizer reserves the right to remove any Sponsor representative whose conduct is deemed inappropriate or disruptive.

6. CANCELLATION AND TERMINATION

- 6.1 If the Sponsor cancels its participation, sponsorship fees shall be non-refundable unless otherwise agreed in writing.
- 6.2 If the Event is postponed or cancelled due to circumstances beyond the Organizer's reasonable control, the Organizer may reschedule the Event or apply sponsorship benefits to a future event.
- 6.3 The Organizer may terminate the sponsorship immediately if the Sponsor breaches these Terms or engages in unlawful or unethical conduct.

7. LIMITATION OF LIABILITY

- 7.1 To the maximum extent permitted by law, the Organizer shall not be liable for any indirect, incidental, or consequential losses arising from the sponsorship or Event.
- 7.2 The Organizer's total liability shall not exceed the sponsorship fees paid by the Sponsor.

8. INDEMNITY

- 8.1 The Sponsor agrees to indemnify and hold harmless the Organizer against any claims, damages, or expenses arising from the Sponsor's materials, activities, or breach of these Terms.

9. FORCE MAJEURE

- 9.1 Neither party shall be liable for failure or delay in performance due to events beyond reasonable control, including but not limited to natural disasters, pandemics, strikes, or government actions.

10. CONFIDENTIALITY

- 10.1 Any confidential information exchanged in connection with the sponsorship shall be kept confidential unless disclosure is required by law.

11. GOVERNING LAW AND JURISDICTION

- 11.1 These Terms shall be governed by and construed in accordance with the laws of the applicable jurisdiction stated in the Sponsorship Agreement.

12. GENERAL

- 12.1 These Terms, together with the Sponsorship Agreement or Proposal, constitute the entire agreement between the parties.
- 12.2 Any amendments must be in writing and signed by both parties.
- 12.3 If any provision is held invalid, the remaining provisions shall remain in full force and effect.
